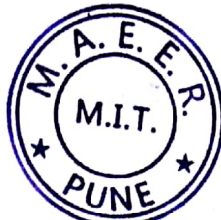
NOTICE No.(4)

- 1) As per Savitribai Phule Pune University Circular No.PGS/779 dt. 02-06-2020 the Commencement of Ist Term for the Academic Year **2020-21** is from Monday, the 15th June 2020 but Actual classes will be started from 1st August 2020.
- 2) Students are required to seek provisional admission and Pay the fee Online through NEFT / RTGS on MIT Bank A/c. No. 053010110000018 , IFSC Code : BKID0000530 , Name : Maharashtra Institute of Technology, Pune, S.No. 124, Paud Road, Kothrud ,Pune -38 Branch : Bank of India MIT Pune. The payment will not be accepted in Cash or by Cheque/DD.
- 3) After online payment student must send the Transaction ID on E-mail ID : i.e. accounts.mit@mitpune.edu.in & CC to studentsection.mitpune@gmail.com for confirmation of payment.
- 4) **College Annual Fee Structure** is given in the Attached Statement and the **Payment Schedule** is as follows:

- 5) Forms for Renewal of Admission are available in the Student Section during the working hours at Rs. 350/- (to be paid in cash only). from 1st August 2020.
- 6) The students should pay full amount of fees (as applicable) to renew their admissions without waiting for their results. After the declaration of the results, non-eligible students will get refund of their fees as per college rules & regulations, by deducting Rs.200/- as Administrative Charges. They have to submit their request applications for refund of fees along with original fee receipt as well as I-Card, to get the refund within a period of one week.
- 7) The **Reserve Category** students applying for the Government Scholarship or Freeship, must submit the following documents at the time of Renewal of their Admissions:
 - i) **Income Certificate** valid for the Financial Year 2019-20 (e.g. Form No.16 for salaried person and Certificate from Tahasildar for other persons).
 - ii) **Previous Year's Income Certificate** in which they had taken Admission in First Year or directly to Second Year. [As per Govt.Rule, Gross Income limit for sanctioning the Scholarship / Freeship for VJNT, OBC & SBC students is Rs.8.00 Lakh]
 - iii) Photo copy of Caste Validity Certificate.

If any one of the documents as mentioned at Sr.No.7 is not produced at the time of admission, the students will have to pay full amount of college fees.
